

AGREEMENT OF COOPERATION

BETWEEN

Ignacy Łukasiewicz Rzeszów University of Technology
situated in 35-959 Rzeszów (Poland), al. Powstańców Warszawy 12
(hereinafter referred to as "RUT") of the one part

AND

Uzhhorod National University
situated in Uzhhorod (Ukraine), Narodna Square 3, 88000, Ukraine,
Transcarpathian region, Uzhhorod (hereinafter referred to as "UzhNU") of the
other part.

A. RUT and UzhNU are desirous of working in a spirit of cooperation to establish academic links between the two institutions, with particular emphasis on academic collaboration, joint research and staff exchange.

B. RUT and UzhNU are desirous of commencing academic links in the first instance through intensifying existing collaborative activities between RUT and UzhNU.

THE PARTIES AGREE:

1. Areas for cooperation

- 1.1. exchange for students, teachers and researchers (including advanced staff training);
- 1.2. reciprocal invitations to scholars for the purpose of talks, lectures and research;
- 1.3. planning and implementing joint research projects;
- 1.4. jointly organized academic events;
- 1.5. exchange with documentary materials.

2. Directions of cooperation

The main special directions of the cooperation will be including the following:

- 2.1. creation of condition for students from both universities to study in and graduate from the partner university in specialties represented in both universities;
- 2.2. joint work of university teachers for the unification of educational programs;
- 2.3. realization of joint projects on design of educational software;
- 2.4. realization of joint research on different spheres of science.

3. Exchange of information

The parties will exchange information on academic events, conferences and symposia and projects organized or initiated by the two partners.

4. Sources of finances

The parties will look for own and external resource to support joint programs.

5. Protocol on Academic Cooperation

The parties will work together to prepare a protocol on academic collaboration which will specify details governing the cooperation between RUT and UzhNU at least for one year.

6. Nominated coordinators

The following persons are appointed as representatives of the parties to facilitate cooperation between RUT and UzhNU:

Izabela Skrzypczak assumes responsibility for coordinating the collaboration on behalf of RUT

Nataliya Kablak assumes responsibility for coordinating the collaboration on behalf of UzhNU.

The representatives shall assist and advise the President/Rector of their universities and other persons, involved to the activity, in all matters relating to the cooperation of the two universities.

7. Commencement and duration

The Agreement is put in force from the moment of its signing. It can be stopped by each of the Universities by informing the other side.

8. The Agreement is subject to Polish law.
