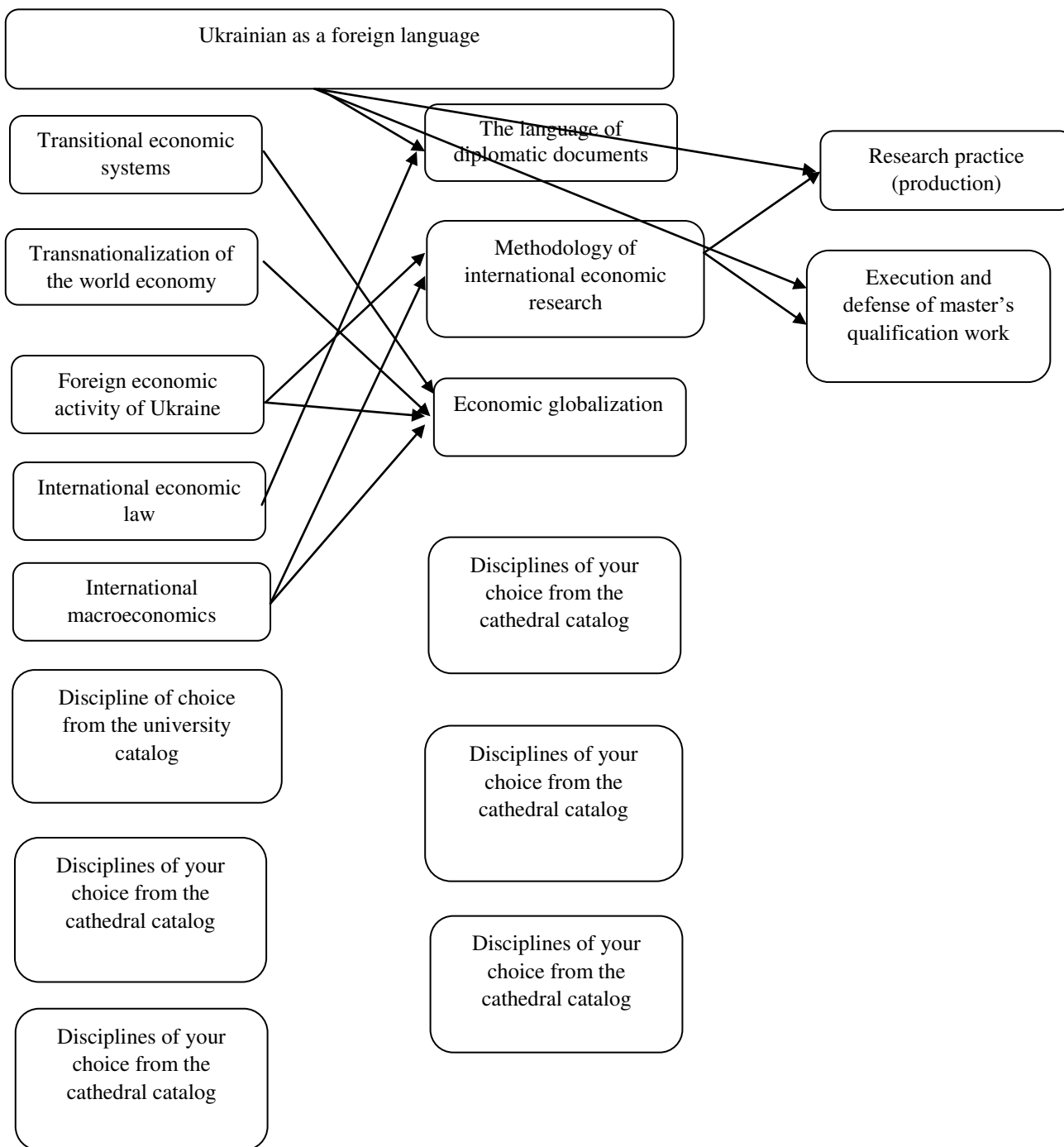

The report should be accompanied by presentation materials and an explanatory note for general review.</p> <p>The decision of the examination commission to award the master's degree in international economic relations and the issuance of a diploma based on the results of the final attestation of students are announced after the minutes of the examination commission are drawn up in accordance with the established procedure.</p>
