COOPERATION AGREEMENT

1. SIGNATORY PARTIES:

1.1 The "Vasile Goldis" Western University Arad, with the headquarters in Arad, 94 – 96, Revoluției Blvd., 310025, Romania, represented by Rector, **Prof. Habil. Coralia Adina Cotoraci, MD, PhD.**

and

1.2 Uzhhorod National University, with headquarters in Uzhhorod, 46, Pidhirnastr., 88000, Ukraine, represented by Rector, **Prof. Volodymyr Smolanka, MD, PhD, DSc**

2. PURPOSE OF THE AGREEMENT

2.1 The purpose of the agreement is represented by the following categories of activities, jointly organized in the interest of each part, in all the domains of common interest.

2.1.1 Promoting the mutual academic exchange of teachers and scientific research staff as well as students, according to the academic resources and available financial means.

2.1.2 The development of joint research projects and the mutual support to secure available research funds in all domains of common interest.

2.1.3 The stimulation and consolidation of reciprocal exchange of information, documents, scientific publications and experience between the two countries.

2.1.4 The organization of international conferences, seminars, symposia, courses and summer schools of mutual interest to the parties.

3. RIGHTS AND OBLIGATIONS

3.1 The partner institutions will organize joint scientific manifestations, projects and research activities.

3.2 The partners to this agreement will inform with at least 6 months prior to the day of the start of the project about its research and financial conditions pertaining to the implementation of the project.

3.3 Regarding the mutual exchanges of academic, research staff and students, it is the responsibility of the home institution to cover the travel costs, and the host institution will support the accommodation costs during the exchange.

3.4 It is the responsibility of each person to cover health insurance for the exchange, according to the laws and regulations of the individual countries.

3.5 The two partner institutions will do their best to find and invite other organizations and parties interested to give financial support to the projects. As to the mobility of students, a balance should be reached, for a medium term, between the number and duration of student exchanges for both institutions.

4. DURATION OF THE AGREEMENT

4.1 The agreement becomes valid when signed by both parties, and is valid for a period of **5 years** that can be prolonged on mutual consent.

4.2 The agreement may be terminated before the deadline, with the consent of the other party, after notice in writing 30 (thirty) days prior to the date indicated.

5. FINAL CLAUSES

5.1 This partnership agreement is the will of the parties and invalidates any previous verbal agreement they concluded.

5.2 Though the activities and the actions are set, the collaboration can be extended to other activities or domains by common consent.

5.3 The present agreement was signed on November 20, 2024, printed in 2 (two) original copies, in English.
